<b>Item 5 : Entry Age</b>	Entry is available to persons over 18 years of age

Receipts must be for a participating retailer and be for a purchase made on the day of entry for \$60 or more on a single transaction. Every entry will also go into the draw for the Shopping Spree
<b>Are Multiple Entries Permitted</b>	No, only one prize can be randomly selected per email address.
