## The Pines Elanora Free Beach Bag Giveaway Terms & Conditions



### SCHEDULE

<b>Item 1: Promotion</b>	The promotion rewards shoppers who spend \$150 in Aldi, Coles, Kmart or Woolworths or \$60 or more in specialty retailers with a GIFT WITH PURCHASE.
<b>Item 2: Promotional Period</b>	From 9.00am Monday 19 September until 4.00pm Saturday 1 October 2022 excluding Sunday 25 September
<b>Item 3: Promoter</b>	The Pines Shopping Centre (QLD) ACN 055 688 607 of PO Box 4100, Elanora, Qld 4221
<b>Item 4: Participating Retailers at The Pines Elanora</b>	The MAJOR retailers are Aldi, Coles, Kmart, Woolworths and all other shops are specialty retailers
<b>Item 5: Entry Age</b>	Entry is available to persons over 18 years of age
<b>Item 6: Gift Pool</b>	Total gift pool being given away is valued at over \$15,000 RRP. The gift pool includes 2,400 summer co-branded beach bags.
<b>How to Enter</b>	Entry can only be achieved by purchasing goods or services. To enter the promotion, each shopper must, during the promotion, make a \$60 or more purchase from a participating specialty retailer, up to THREE receipts may be added together to reach \$60 or more, or spend \$150 in ONE transaction at Kmart, Coles, Woolworths or Aldi The Pines Elanora. Excludes all types of bill payments at banks, post offices and other similar payments such as insurance premiums, lottery and smoking purchases. Layby payments are excluded unless the payment is a final instalment. Customers take their valid receipt/s to the roaming promotional cart during the hours of 10am-4pm to redeem their gift. Customers will be required to provide the following data via a QR code entry using their smart phone; Names, Post Code, email address, value of purchases made and if at the specialty shops or a major shop. Then show the resulting message and their valid receipts to the promotion person for validation. These details may also be provided to the promotion person at the cart. Customers may choose if they wish to join our mailing list. A maximum of 200 bags per day are available for redemption.

<b>Are Multiple Entries Permitted</b>	Only one gift per person per day can be redeemed.
<b>Changes due to Queens Mourning Period or other changes to normal trading announced</b>	The promoter reserves the right to suspend the promotion for any public holiday announced during the promotion period and to extend the campaign by at least the number of suspended days, which would be after the normal promotion period. Any extension of the promotion would be by collecting bags from Centre Management Office in NORMAL office hours.

### INTRODUCTION

- Information on how to enter and gift details form part of the overall terms and conditions.
- By participating in the promotion, entrants accept and agree to be bound by the terms and conditions. For the avoidance of doubt, the terms and condition include the schedule above.
- Entries must comply with these terms and conditions to be valid.
- Where there is an inconsistency between the schedule and terms and conditions, the schedule will prevail.

### PRIVACY

- The Promoter will collect and use the entrants personal information (name, post code and email) for the purpose of processing and conducting the promotion and for promotional purposes including but not limited to media releases etc.

- Research to improve service and Pines Marketing campaigns
  - Auditing of the gift allocation
- By entering the promotion, entrants consent to use their personal information as outline in clause 5 above.

### WHO CAN ENTER THE PROMOTION

- If the Schedule permits entrants to be under the age of 18 years, such entrants must seek permission from their parent or guardian to enter. If the winner of a Gift is under 18 years of age, the Gift will be awarded to the winner's parent or legal guardian.
- Directors and employees (and their immediate families) of the Promoter or its related companies or agencies and Participating Retailers are not eligible to enter. Immediate families means spouse, ex-spouse, de facto partner, ex-de facto partner, child, step-child, parent, step-parent, legal guardian, sibling or step-sibling.

### HOW TO ENTER THE PROMOTION

- To enter, each entrant must comply with the 'how to enter' detailed in the schedule.
- The Promoter reserves the right to disqualify any entrant who provides false information or fails to provide information that is reasonably requested by the Promoter.
- The Promoter reserves the right, in its sole discretion, to refuse to accept entries which are incomplete, indecipherable, offensive, do not comply with these terms and conditions or which contravene any applicable laws or regulations.
- The eligibility of entries is solely within the discretion of the Promoter.
- The Promoter accepts no responsibility for late, lost, misdirected or damaged entries or other communications.

### GIFTS

- Each gift is not transferable, exchangeable or redeemable for cash.
- If a gift is unavailable for reasons beyond the Promoters control, the Promoter reserves the right substitute a gift with an equal greater value.
- Once the gift has left the Promoters premises, the Promoter takes no responsibility for the gift should it be damaged, lost or stolen.
- The winners use of a gift is entirely at their own risk.

### ALLOCATION OF GIFTS

- Each person completing the "how to enter" correctly will be awarded a Beach bag.
- The mechanism for determining winners is solely within the discretion of the Promotion.
- The bags are limited to one redemption per person per day.
- Once a day's allocation of bags is exhausted there will be no more bags available for that day.

### CLAIMING GIFTS

- The gifts must be collected as per the instruction in how to enter, note that should there be changes due to the Queen's Mourning period then collection will be as detailed in the schedule.

### LIABILITY

- Any Gift supplied by a third party supplier is subject to the terms and conditions of the third party supplier. Each gift may come with guarantees that cannot be excluded under Australian Consumer Law. If those guarantees are not complied with, then you will have rights under the Australian Consumer Law. Subject to those guarantees and rights, the Promoter shall not be liable and excludes all liability (including negligence), for any loss or damage whatsoever which is suffered (including but not limited to indirect or consequential loss) for damage to property, personal injury or death suffered or sustained in connection with the Promotion or the use or taking of any Gift except for any liability which cannot be excluded by law including as provided for under the Australian Consumer Law.

### TERMINATION

- The Promoter reserves the right to vary the terms of, or cancel the promotion at anytime without liability to any entrant or other person, subject to applicable laws.
